* Additional Reasons for Cancellation

- necessary repetition of a failed examination by the insured person at a school/university, provided that the repeat examination takes place unexpectedly during the travel period or within 14 days of the scheduled end of the trip and the trip was booked before the date of the failed examination.
- Failure of the insured person to progress to the next school level if the trip is a school trip;
- Failure by the insured person to pass a final class of a school education of at least 3 years' duration immediately before the date of the insured trip.
- Unexpected change of school or dropping out of school immediately before the travel date

I am aware that in the event of an early return home (homesickness, etc.), the costs of return transport must be borne by me and no refund of the course fee will be made. In case of dissatisfaction on my part, I must inform the organiser <English Institute> immediately. Participants of the student courses may be sent home at their own expense in the event of breaches of order or criminal offences (e.g. theft, drugs, alcohol) after informing their parents or guardians. I also acknowledge that there is no uninterrupted supervision and therefore the organiser is not liable for any accidents. I am responsible for all costs not covered by the English Institute's accident and liability insurance and do not make any further claims. I agree to pay for all damages resulting from my daughter's/son's misconduct, even if not covered by my personal liability insurance.
